- Our 926 District API score ranks us #3 in the state of California when compared to other unified school districts.
- Bill Fauver (Mira Costa) was not only named the 2010-2011 MBUSD Teacher of the Year, he was honored as one of Los Angeles County's Teachers of the Year.
- Linda Okumura (Pacific) is the 2011-2012 MBUSD Teacher of the Year.
- We had our first ever STEM (Science, Technology, Engineering and Mathematics) class – an all girls class at that – taught by Stacey Cooke in the middle school. They won a national award from NASA and their science game will be played by astronauts on the International Space Station this summer!
- Carey Sokol, the Occupational Therapist at Grand View Elementary, is the MBUSD Classified Employee of the Year.

- IXL Math was the District's first online math program. MBUSD elementary students were able to practice grade level math standards in an online format that is differentiated to meet their individual needs.
- Mira Costa High School was named a California Distinguished School
