Student Board Member Report

Sierra Bloodgood and Emily Goldenberg, student Board members, discussed student topics at Mira Costa High School, elementary schools, and events and activities in the District. Dana Sheckter reported on activities at Manhattan Beach Middle School.

Internet Safety and Cyber-Bullying

Mrs. Schneider reviewed the risks associated with children using the internet. She said that girls are more likely to be victims and children who share their identities and thoughts online are more likely to be targets.

Mrs. Schneider pointed out the statistics regarding children on the internet: 58% have not told parents about an online bullying incident; 21% of children have received mean/threatening email or other messages; 13% have been the subject of rumors online; 7% have had someone impersonate them online; 8% have reported receiving a threatening phone call or text, and 5% have had a mean or hurtful picture posted on the internet.

The steps taken during the 2009-2010 school year to educate both staff and students were outlined. Administrative Regulation 5131.2(a), Bullying and Cyber-Bullying/Harassment, was developed as part of Conduct Policy 5131.

Mrs. Schneider indicated the next steps would include continuing the presentations by the SRO's, expanding the parent presentations to all schools, review existing curriculum, and continue to review relevant board policies to determine if revisions are needed.

Addition to Staff Development Days

Mrs. Howorth moved approval of the recommendation to offer up to two optional staff development days (12 hours) for MBUTA unit members for the 2010-2011 school year. Superintendent/Cabinet

Report

Saxon Math

The Board recently discussed a change in the elementary math curriculum. The change will allow an upgrade to the most recent Saxon math books, as the old ones are harder to purchase. More

importantly, the new books are more in line with the California Standards. The 2^{nd} grade curriculum used to combine 2^{nd} and 3^{rd} grade standards, leaving out many 2^{nd} grade standards. The new 2^{nd} grade curriculum focuses solely on 2^{nd} grade standards, while the new 3^{rd} grade curriculum focuses solely on 3^{rd} grade standards. Fourth and 5^{th} grade math curricula have not changed.

This year's third graders face the challenge of repeating some of the third grade standards they learned last year. Therefore, teachers face two challenges:

- (1) How to differentiate instruction in the classroom so that students of all abilities are challenged, and
- (2) How to provide homework that is differentiated and challenging to all students.

IXL Math, a 21st Century way of providing differentiated online instruction, is now available for staff, students and parents.

There are now storage facilities on shared servers where teachers can share their best lesson plans and best ideas for teaching all levels of students.

More in-services are planned on maximizing the resources, both print and online, that Saxon, our math textbook company, has to offer.

These changes will not just impact third grade math. IXL and the shared drive are available for all levels of elementary mathematics, and maybe beyond.

21st Century Curriculum

Effective 21st Century schools not only use the resources available in the 21st Century, but they guide students and help them not only to access all online resources, but help them to acquire media literacy, so they can access those resources safely and wisely.

Through a generous grant to the Education Foundation, there is a Teacher on Special Assignment, Karina Gerger, working with Executive Director Carolyn Seaton to help us move toward 21st Century teaching and learning.

The math strategies described earlier are perfect examples of this. Both Ms. Gerger and Mrs. Seaton have been vital in this effort. Staff will come to the Board in January to report on this effort.

Superintendent's Fiscal Advisory Committee

This committee worked for two years with two primary goals:

- 1. To make the budget process as transparent as possible, bringing in key constituents to examine and understand the budget.
- 2. To develop ideas for increasing revenues and decreasing expenditures that the District can explore.

The Energy Consultant is a direct result of last year's work from this

committee. The first meeting will be on November 9th, from 9-11:00 a.m., in the guidance counseling conference room at Mira Costa High School.

MBEF Pledge Day
